Project Overview:

The Committee for Hispanic Children & Families (CHCF) is seeking proposals from qualified contractors to perform mold remediation services at its facility located at 450 Castle Hill Ave., Bronx, NY 10473. The facility has experienced water damage and mold growth in various areas, including the basement and first floor. The selected contractor will be responsible for the safe and effective removal of mold and the restoration of affected areas to a safe and habitable condition.

Scope of Work:

The selected contractor will be responsible for the following:

- **Containment:** Establish containment barriers and negative air pressure to prevent the spread of mold spores during the remediation process.
- **Mold Removal:** Remove all visible mold and mold-contaminated materials, including drywall, insulation, ceiling tiles, and flooring.

- Insurance and Licensing: Provide proof of insurance and all required licenses.

Evaluation Criteria:

Proposals will be evaluated based on the following criteria:

- **Experience and Qualifications:** The contractor's experience and qualifications in mold remediation and restoration.
- **Technical Approach:** Proposed methodology, materials, and equipment.
- **Cost**: Competitiveness of the proposed price.
- Warranty: Strength and comprehensiveness of the warranty offered.
- **References**: Feedback from previous clients on similar projects.
